**RE: Authorization to Proceed with Reroute of Old Gravel Point Cemetery**

Dear Mr. Allen:

I approve ETC Tiger Pipeline, LLC's (ETC Tiger) July 22, 2010 request to reroute a portion ETC Tiger's pipeline extending about 263 feet in length to avoid the Old Gravel Point Cemetery in Desoto Parish, Louisiana, as identified in your filing. Your request is in compliance with environmental condition 5 of the Commission's Order authorized on April 4, 2010 (Order).

We have confirmed receipt of all federal authorizations relevant to the approved activities and have received concurrence with ETC Tiger's Treatment Plan for the Old Gravel Point Cemetery (Treatment Plan) filed on July 15, 2010 from the Louisiana State Historic Preservation Office. You may now implement the measures outlined in the Treatment Plan.

Please note that this approval does not allow the use of areas other than those specified above. I remind you that ETC Tiger must comply with all applicable remaining terms and conditions of the above-referenced Order, as well as procedures stipulated in its previous filings.
